The board has the authority to review complaints and disputed administrative action and make recommendations for disciplinary action to the division at the request of the license holder, permit holder, or certificate holder. The board serves in an advisory capacity to the division regarding rules, codes, standards, interpretations, and training.

The two fire equipment representatives on this important board are John Gioseffi, Broward Fire Equipment, Ft. Lauderdale (currently serving as chair of the board) and Gary Blair, Fire Fighter Inc. Both have served as presidents of FFEDA with Gary currently serving as President and John currently serving as Treasurer on the FFEDA Board of Directors.
