

2024 FFEDA TERMS OF EXHIBITOR/SPONSORSHIP AGREEMENT

1. AGREEMENT

The following terms shall become binding upon acceptance of this agreement between the applicant and his/her employees and the Florida Fire Equipment Dealers Association (FFEDA), the meeting and exhibit host.

12:00 p.m. – 2:00 p.m. Saturday, June 22

3. PUBLIC POLICY

Exhibitors are charged with knowledge of all ordinances and regulations pertaining to taxes, health prevention, customs and public safety while participating in this event. Compliance with such laws is mandatory for exhibitors and the responsibility of the exhibitor.

4. USE OF EXHIBIT SPACE

Exhibitors shall reflect their company's highest standards of professionalism while maintaining exhibit space during trade show hall hours. No exhibitor shall assign, sublet or share the space without the written permission of FFEDA.

5. DAMAGE TO PROPERTY

Exhibitors are liable for any damage caused to building, floors, walls, columns, or to standard exhibit equipment or to other exhibitor's property. Exhibitors must not apply paint, lacquer, adhesive or any other coating to building, columns, floors, or to standard exhibit equipment.

6. FOOD SERVICE

FFEDA reserves the right to provide food and beverage service in the trade show hall.

7. CANCELLATION

No cancellation shall be acknowledged unless received by FFEDA's Tallahassee office in writing by email, fax or mail. Should an exhibitor wish to cancel 30 days or more before the set-up date, a 50% refund will be made by FFEDA; no refunds will be made for cancellations with less than 30 day's notice. Sponsors who wish to cancel must submit a written cancellation request to the FFEDA office 60 days prior to the conference to receive an adjusted refund based on expenses related to said sponsorship that may have already been spent. All sponsorship cancellation requests received with less than 30 day's notice will receive up to a 50% refund of the fees paid.

8. FIRE AND SAFETY REGULATIONS

All local regulations will be strictly enforced and the exhibitor assumes all responsibility for compliance with such regulations. Fire hose cabinets and fire exits must be left accessible and in full view at all times. All disposable materials and decorations must be flameproof and subject to inspections.

9. LIABILITY AND INSURANCE

The hotel management and FFEDA will take all reasonable precautions to avoid the loss of exhibitor's property by theft or fire, but under no circumstances shall the hotel management or FFEDA be responsible for such losses, and it is recommended that exhibitors cover their property with suitable insurance.

10. ELIGIBLE EXHIBITS

FFEDA reserves the right to determine the eligibility of any company or products for inclusion in the meeting and reserves the right to reject, evict or prohibit any exhibit in whole or in part, or any exhibitor, or his representatives, with or without giving cause.

11. NOISY AND OBNOXIOUS EQUIPMENT

The operation of whistles or any objectionable device will not be allowed. After the trade show hall opens, noisy and unsightly work will not be permitted.

12. EXHIBITOR SALES TAX

Per Florida tax laws, this agreement prohibits the exhibitor from making or offering to make sales of taxable goods or services without obtaining an Annual Resale Certificate (Form DR-13) from the purchaser.
