- All Fire Equipment Dealer License Holders (licensees) must have a minimum of: 14 hours of Technical content, 1 hour Business Practices, 1 hour Workers Compensation
- All Fire Equipment Permit Holders (permittees) must have a minimum of: 14 hours of Technical content, 1 hour Business Practices, 1 hour Workplace Safety
